Found in numerous pines, red maple, silver maple, aspens, cottonwoods, hemlocks, sumac, cedar, junipers...etc.



γTerpinene

One of four isomers of the monoterpene Terpinene. It has a fragrance that can be described as sweet, spicy, tropical, woody and oily with a hint of citrus. Found in marjoram, cardamom, tea tree, bible hyssop...etc.



Geranyl Acetate

A monoterpenoid ester with a fragrance that can be described as floral, fruity, waxy and herbal. Found in lemongrass, palmarosa, geranium, sassafras, carrot, coriander, bitter orange, Camden woollybutt...etc.


